Did you know?

The NRL Project is included in the Physical Activities Regulation under the Impact Assessment Act. Therefore, an Initial and Detailed Project Description must be submitted to the Impact Assessment Agency of Canada. The Agency will then determine if the Project is subject to a Federal Impact Assessment (IA). If the Project is subject to a Federal Impact Assessment, the Agency will prepare a Tailored Impact Statement Guidelines which outlines what needs to be studied as part of the IA. A coordinated EA/IA process would be used to satisfy both the Federal and Provincial processes.


