# NOTICE OF SUBMISSION OF TERMS OF REFERENCE Northern Road Link Project Environmental Assessment




Marten Falls First Nation (MFFN) and Webequie First Nation (WFN) have prepared a Terms of Reference (ToR) for an Individual Environmental Assessment (EA) for the Northern Road Link project ("the Project"). The ToR has been submitted to the Ministry of the Environment, Conservation

and Parks (MECP) for review as required under the Ontario *Environmental Assessment Act*, RSO 1990, c. E.18. If approved, the ToR will serve as a framework for the preparation and review of the EA for the Project. As part of the submission process, Indigenous communities, the public, agencies, and other interested parties are encouraged to review the ToR and submit comments to the MECP.

## **Project Description**

The communities of MFFN and WFN are remote Indigenous communities in northwestern Ontario and are not currently accessible by all-season roads. The proposed Project is a multi-use road and associated infrastructure between the proposed Marten Falls Community Access Road (MFCAR) and the proposed Webequie Supply Road (WSR). The Project will connect the Ring of Fire mineral deposits in the McFaulds Lake area to the highway network via the proposed MFCAR, by constructing a new all-season multi-use road with an approximate length of 117 km to 164 km (depending on the chosen corridor). The Project would enable economic activity by facilitating the transport of goods, services and resources. The preliminary Northern Road Link route alternatives being carried forward to the EA are shown in the accompanying figure.



## The Process

MFFN and WFN have entered into a voluntary agreement with the MECP to subject the Project to Ontario's *Environmental Assessment Act.* The Proposed ToR considered comments received by MFFN and WFN on the Draft ToR. The Proposed ToR includes an outline of the studies, evaluation of alternatives to be considered, and consultation activities that will be carried out during the EA. If approved by the Minister of the Environment, Conservation and Parks, the ToR will serve as a framework for the preparation and review of the EA for the proposed Project. Important elements of the EA will be to evaluate the alternatives, assess potential effects and determine measures to reduce or mitigate these effects.

#### **Review of the Proposed Terms of Reference**

Members of Indigenous communities, the public, agencies, and other interested parties are encouraged to review the Proposed ToR and provide comments from April 29 until June 28, 2022.
