Did you know?

The NRL Project is included in the Physical Activities Regulation under the *Impact Assessment Act*. Therefore, an Initial and Detailed Project Description must be submitted to the Impact Assessment Agency of Canada. The Agency will then determine if the Project is subject to a Federal Impact Assessment (IA). If the Project is subject to a Federal Impact Assessment, the Agency will prepare a Tailored Impact Statement Guidelines which outlines what needs to be studied as part of the IA. A coordinated EA/IA process would be used to satisfy both the Federal and Provincial processes.


Proposed ToR: Comment Themes Received To Date
